Founded in 1906 as a private higher education establishment, the **Kyiv Graduate Commercial Courses** were tasked to train human resources for the south part of Russian Empire.





KNEU's history

In 1997, the President of Ukraine granted **Kyiv State Economic University** the status of a national university in recognition of its substantial work focused on training highly qualified specialists and the development of the economic science.

In 2005, Kyiv National Economic University was named after **Vadym Hetman**, a prominent Ukrainian economist and the founder of the domestic currency of Ukraine, the builder of its banking sector.
